upper: lead-grey split suede leather declared thickness 1.8/2.0 mm (PL00039) and black 10 fishnet knitting VERTEX (S100723); with a black polymeric insert in the heel area, marked "BREATHABLE", with lateral holes closed by means of a fabric/membrane; rear collar: dark grey Lycra MOREA (S100751) padded with a black folded Lycra edge

(AT01766); the collar has been shaped to create a loop to ease the donning;

tongue: black fishnet knitting AIRNET (\$100151), lined and padded;

bellows: black coated synthetic fabric SPICE (\$100002);

vamp lining: grey three-dimensional fishnet knitting IMOLA coupled with black canvas

heel-grip lining: anthracite grey non-woven fabric THORIN (\$100283);

<u>insole</u>: white multilayered fabric with a black print declared conductive art. WB FLEX (\$P00007), which also serves as penetration resistant insert;

removable insock: grey perforated foam material coupled with a black knitting with "WOW!" stamp in contact with the user, with zig-zag stitching with conductive thread in the forepart (TL 00161);

toecap: alluminum, art. A522 MARTEK (PU00041).
