- grey split suede leather (PL00058);

collar: retroreflective insert made of coated fabric (S100245);

<u>vamp lining</u>: grey three-dimensional fishnet knitting coupled with black canvas (\$100743); rear lining; light grey three-dimensional fishnet knitting (\$100468);

rear collar lining and tongue lining: yellow three-dimensional fishnet knitting (\$100485);

tongue: as the same materials of the upper, lined and padded;

insole: white fabric with green printing, declared conductive IBISAFE D28-K35 BIAGIOLI

(SP00036), which also serves as penetration resistant insert;

removable insock: grey perforated foam material coupled with black knitting with printing "U-POWER ORIGINAL" in contact with the user, with double zig-zag stitching with conductive thread in the forepart (TL00180);

toecap: aluminum, art. A522 MARTEK (PU00044).

Functions and performance levels:

**basic requirements for safety footwear** (see Table 2 and 3 of EN ISO 20345:2011): all mandatory ones, among which:

**SRC = Slip resistance** – meets the following requirement:

- <u>surface</u>: ceramic / <u>lubricant</u>: <u>detergent</u> solution;
- surface: steel / <u>lubricant</u>: glycerol.

Additional requirements (Tab. 18 and 20 of EN ISO 20345:2011):

**S1** = closed seat region, antistatic properties, energy absorption of seat region, resistance to fuel oil; **P** = penetration resistance of the sole.

Note 1: the penetration resistance of the synthetic stitch proof insole tends to decrease with the diameter of the perforating object; in return the synthetic insole offers more protective surface and ergonomics advantages (flexibility, insulation, humidity and impact absorption).

Note 2: the footwear also meets the requirement in accordance with IEC 61340-5-1:2016 (IEC 61340-4-3:2017) for the electrical resistance **ESD** (electric dissipative footwear).

Marking:

on a stitched label and displaying the following information:

- CE Marking;
- registered trademark, name and complete address of the Manufacturer;
- designation of the footwear (= article name and alphanumeric code);
- nr. and year of the Standard of reference + safety symbols;
- size of the footwear (printed on the outsole);
- production date (month + year);
- additional information: website, category of the PPE, "Made in ...".
