collar: black fabric coupled with PE (S100047);

tongue: black fabric (\$100046), centrally lined and padded;

vamp lining: grey three-dimensional fishnet knitting coupled with black canvas (\$100743);

rear lining: black three-dimensional fishnet knitting (\$100466);

tongue and rear collar lining: light grey three-dimensional fishnet knitting (SI00468);

<u>insole</u>: white multi-layered fabric with black print declared conductive, art. WB FLEX (SP00007), <u>which also serves as penetration resistant insert</u>;

removable insock: grey perforated foam material coupled with black knitting with WOW! stamp in contact with the user, with zig-zag stitching with conductive thread in the forepart (TL00161);

toecap: aluminium, art. A522 MARTEK (PU00041).

Functions and performance levels:

basic requirements for safety footwear (see Table 2 and 3 of EN ISO 20345:2011): all mandatory ones, among which:

SRC = Slip resistance – meets the following requirement:

- <u>surface</u>: ceramic / <u>lubricant</u>: detergent solution;
- surface: steel / <u>lubricant</u>: glycerol.

Additional requirements (Tab. 18 and 20 of EN ISO 20345:2011):

S3 = closed seat region, antistatic properties, energy absorption of seat region, resistance to fuel oil, water penetration resistance and absorption (water-repellent upper), penetration resistance, cleated outsole; **CI** = cold insulation of the sole complex.

Note 1: the penetration resistance of the synthetic stitch proof insole tends to decrease with the diameter of the perforating object; in return the synthetic insole offers more protective surface and ergonomics advantages (flexibility, insulation, humidity and impact absorption).

Note 2: the footwear also meets the requirement in accordance with IEC 61340-5-1:2016 (IEC 61340-4-3:2017) for the electrical resistance **ESD** (electric dissipative footwear).

Marking:

on a stitched label and displaying the following information:

- CE Marking;
- registered trademark, name and complete address of the Manufacturer;
- designation of the footwear (= article name and alphanumeric code);
- nr. and year of the Standard of reference + safety symbols;
- size of the footwear (printed on the outsole);
- production date (month + year);
- additional information: website, category of the PPE, "Made in ...".
